ORDER

On October 1, 2018, Peoples Gas KY, LLC (Peoples), filed its proposed Gas Cost Recovery (GCR) rate application to be effective November 1, 2018.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Peoples' application includes a revised rate designed to pass on to its customers its expected change in gas costs.
2. Peoples' application sets out an Expected Gas Cost (EGC) of \$5.1369 per Mcf.
3. Peoples' application sets out no Refund Adjustment.
4. Peoples' application sets out a current quarter Actual Cost Adjustment (ACA) of \$.3385 per Mcf and a total ACA of \$.9247 per Mcf.
5. Peoples' application sets out a current quarter Balance Adjustment (BA) of (\$.0147) per Mcf and a total BA of \$.0178 per Mcf.
6. Peoples' GCR rate is \$6.0794 per Mcf, which is an increase of \$.04450 per Mcf from its previous rate of \$5.6344 per Mcf.

7. The rate as proposed by Peoples and set forth in the Appendix to this Order is fair, just, and reasonable, and should be approved for final meter readings by Peoples on and after November 1, 2018.

IT IS THEREFORE ORDERED that:

1. The rate proposed by Peoples and set forth in the Appendix to this Order is approved for final meter readings on and after November 1, 2018.

2. Within 20 days of the date of entry of this Order, Peoples shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rate approved herein and reflecting that it was approved pursuant to this Order.


3. This case is closed and removed from the Commission's docket.
