ORDER

On September 24, 2018, Delta Natural Gas Company, Inc. (Delta), filed its proposed Gas Cost Recovery (GCR) application to be effective October 24, 2018.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Delta's application includes revised rates designed to pass on to its customers its expected change in gas costs.
2. Delta's application sets out an Expected Gas Cost (EGC) of \$3.8492 per Mcf.
3. Delta's application sets out no Refund Adjustment.
4. Delta's application sets out a current quarter Actual Adjustment (AA) of (\$.2909) per Mcf and a total AA of \$.7017 per Mcf.
5. Delta's application sets out a current quarter Balance Adjustment (BA) of \$.0389 per Mcf and a total BA of \$.0049 per Mcf.
6. Delta's GCR rate is \$4.5558 per Mcf, which is a decrease of \$1.8513 per Mcf from the previous GCR rate of \$6.4071 per Mcf.

7. The rates as proposed by Delta and set forth in the Appendix to this Order are fair, just, and reasonable and should be approved for final meter readings by Delta on and after October 24, 2018.

IT IS THEREFORE ORDERED that:

1. The rates proposed by Delta and set forth in the Appendix to this Order are approved for final meter readings on and after October 24, 2018.

2. Within 20 days of the date of entry of this Order, Delta shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.


3. This case is closed and removed from the Commission's docket.
