**MOTION TO SUBSTITUTE REDACTED PAGE AND  
TO WITHDRAW APPLICATION**

Pursuant to 807 KAR 5:001, Northeast Woodford County Water District (“Northeast Woodford District”) moves for leave to substitute the page attached to this Motion for a page of its Application containing unredacted confidential information and for leave to withdraw its Application.

In support of its Motion, Northeast Woodford District states:

1. On October 5, 2018, Northeast Woodford District tendered for filing its application for a certificate of public convenience and necessity, authorization to enter an assistance agreement with the Kentucky Infrastructure Authority (“KIA”) and approval of increased rates for water service.

2. Exhibit A of the Application contains a page entitled “Authorization for Electronic Deposit of Borrower Payment.” This page lists the transit number and account number of an account at a financial institution in which Northeast Woodford District maintains funds. With this information a person may gain unauthorized access to that account.

3. In preparing its application, Northeast Woodford District inadvertently failed to redact this information as 807 KAR 5:001, Section 4(10) requires.

4. Substitution of the redacted page for the existing page will prevent the disclosure of the confidential information and protect against unauthorized access to Northeast Woodford District's account.

5. At the time of filing its application, Northeast Woodford District assumed that its Application would be reviewed in accordance with the requirements of KRS 278.023. Upon further review, it has determined that KRS 278.023 would not apply and that its Application must meet the more extensive filing requirements of KRS 278.020, KRS 278.300, and 807 KAR 5:001, Section 16.

6. Northeast Woodford District therefore proposes to withdraw its Application and to submit at a later date an application for a certificate of public convenience and necessity for the proposed waterworks improvements and for authorization to enter an assistance agreement with KIA.

**WHEREFORE**, Northeast Woodford District requests that the Commission:

1. Substitute the redacted page attached to this Motion for the corresponding page contained in Northeast Woodford District's Application;

2. Permit Northeast Woodford District to withdraw its Application and close this docket; and,

3. Grant any and all such other relief to which Northeast Woodford District may be entitled.
