Dear Mayor Meadows and Chairman Thomas:

Several months ago, Cannonsburg Water District filed an Application with the PSC to increase its **retail** water rates. We did **not** seek to increase **wholesale** rates.

On March 19, 2019, the PSC issued its Staff Report in our rate case. The PSC Staff reduced our retail rate increase and recommended that all of our rates, both **retail** and **wholesale**, be increased by approximately **4.07%**. The new wholesale rate recommended by PSC Staff is \$4.60 per 1,000 gallons. This is an increase of 18 cents per 1,000 gallons.

The purpose of this letter is to inform you that the Board of Commissioners of the Cannonsburg Water District has decided to accept the recommendations contained in the PSC Staff Report.

Notice is hereby given that the Cannonsburg Water District plans to increase its wholesale water rate as recommended by PSC's Staff in a report dated March 19, 2019. The proposed rate shall not become effective until the Public Service Commission has issued an order approving this rate.

When the recommended rates are implemented, the monthly bill for Big Sandy Water District, using an average of about 3,900,000 gallons per month will increase from \$17,238 to \$17,940. This is an increase of \$702 or 4.07%. The monthly bill for the City of Greenup, using an average of about 1,000,000 gallons per month will increase from \$4,420 to \$4,600. This is an increase of \$180 or 4.07%.

The rates contained in this notice are the rates proposed by Cannonsburg Water District. However, the Public Service Commission may order rates to be charged that differ from these proposed rates. Such action may result in rates for consumers other than the rates shown in this notice.
