ORDER

On November 26, 2018, Western Lewis-Rectorville Water and Gas District (Western Lewis-Rectorville District) filed its proposed Gas Cost Recovery (GCR) rate to be effective January 1, 2019. After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Western Lewis-Rectorville District's application includes revised rates designed to pass on to its customers its expected change in gas costs.
2. Western Lewis-Rectorville District's application sets out an Expected Gas Cost (EGC) of \$4.4617 per Mcf.
3. Western Lewis-Rectorville District's application sets out a Refund Adjustment (RA) of (\$1.2500) per Mcf.
4. Western Lewis-Rectorville District's application sets out a current quarter Actual Adjustment (AA) of \$.0024 per Mcf and a total AA of (\$.8275) per Mcf. On schedule I of its application, Western Lewis-Rectorville District made a typographical error on the AA calculation section. Western Lewis-Rectorville District listed a current quarter AA of (\$.0024) per Mcf instead of the correct current quarter AA of \$.0024 per Mcf set out in

schedule IV of its application. The total AA was calculated using the correct current quarter AA. The error did not have an impact on the GCR rate.

5. Western Lewis-Rectorville District's application sets out no current quarter Balance Adjustment (BA) and no total BA.

6. Western Lewis-Rectorville District's GCR rate is \$2.3842 per Mcf, which is an increase of \$.3985 per Mcf from the previous GCR rate of \$1.9857 per Mcf.

7. The rates as set forth in the Appendix to this Order are fair, just, and reasonable, and should be approved for service rendered by Western Lewis-Rectorville District on and after January 1, 2019.


IT IS THEREFORE ORDERED that:

2. Within 20 days of the date of entry of this Order, Western Lewis-Rectorville District shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.

3. This case is closed and removed from the Commission's docket.
