Bernheim Arboretum was deprived of due process of law through the Commission's failure to abide by 807 KAR 5:001, Sections 14(1) and 15(2). Those regulations require a separate CPCN application to be filed for the Bullitt County natural gas pipeline project, which application would have allowed for public notice and an opportunity to be heard regarding the need for the pipeline and the reasonableness of the proposed route.
