COMMISSION STAFF'S INITIAL REQUEST FOR INFORMATION  
TO NIXUTIL SANITATION ASSOCIATION, INC.

Nixutil Sanitation Association, Inc. (Nixutil Association), pursuant to 807 KAR 5:001, is to file with the Commission the original and six copies in paper medium of the following information, with a copy to all parties of record. The information requested herein is due on May 17, 2019. Responses to requests for information in paper medium shall be appropriately bound, tabbed, and indexed.

Each response shall include the name of the witness responsible for responding to the questions related to the information provided. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Nixutil Association shall make timely amendment to any prior response if Nixutil Association obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any request to which Nixutil Association fails or refuses to furnish all or part of the requested

information, Nixutil Association shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention shall be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations. When filing a paper containing personal information, Nixutil Association shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

1. Provide a copy of Nixutil Association's bank statements for the period beginning November 1, 2016, and ending December 31, 2018. Please black out any account or routing numbers before filing.
2. Provide a copy of all bills Nixutil paid for the period beginning November 1, 2016, and ending December 31, 2018.
3. Confirm that Nixutil Association provides service for 33 residential customers and 1 commercial customer. If you can not confirm, please explain.
4. Provide a copy of Nixutil Association's most recent discharge permit issued by the Kentucky Energy and Environment Cabinet, Division of Water.
5. State whether customers were provided notice of Nixutil Association's request for a rate adjustment. If notice was provided, provide this notice.
6. Identify any meetings that Nixutil had with customers regarding the application for a rate adjustment by:

- a. Providing the date of each such meeting;
- b. Briefly describing what was discussed at each such meeting;
- c. Describing any votes that were held at each such meeting;
- d. Providing a list, if available, of those in attendance at the meeting;
- e. Describing how customers were provided notice of the meeting; and
- f. Provide all minutes from the meeting.

7. Provide a copy of any other correspondence provided to customers regarding Nixutil's application for a rate adjustment.
