ORDER

On June 17, 2019, Reid Village Water District (Reid Village District) applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Reid Village District purchases water from the Mt. Sterling Water & Sewer System (Mt. Sterling).
2. Mt. Sterling notified Reid Village District that its wholesale water rate to Reid Village District will increase from \$3.11 per 1,000 gallons to \$3.17 per 1,000 gallons effective July 1, 2019.² Reid Village District proposes to increase the water rates to its customers effective July 1, 2019, to reflect the increased cost of purchased water from Mt. Sterling.
3. Reid Village District proposed a purchased water adjustment factor of \$0.08 per 1,000 gallons in its application.

4. During the 12 months ended April 30, 2019, Reid Village District purchased 65,694,470 gallons of water from Mt. Sterling. During the same period, Reid Village District sold 54,995,808 gallons of water. The increase in the cost of purchased water is \$3,941.66, resulting in a purchased water adjustment factor of \$0.08 per 1,000 gallons.

5. The purchased water adjustment factor of \$0.08 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable, and should be approved.

6. Reid Village District's proposed rates should be approved.

7. The rates as set forth in Appendix B to this Order, are fair, just, and reasonable, and should be approved for water service rendered by Reid Village District on and after July 1, 2019.

IT IS THEREFORE ORDERED that:

1. The purchased water adjustment factor of \$0.08 per 1,000 gallons is approved.

2. The rates proposed by Reid Village District are approved.

3. The rates as set forth in Appendix B to this Order are approved for water service rendered by Reid Village District on and after July 1, 2019.

4. Within 20 days of the date of entry of this Order, Reid Village District shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein.


5. Within 30 days of the date of entry of this Order, Reid Village District shall file with the Commission Proof of Notice pursuant to 807 KAR 5:068, Section 5(3).

6. Any document filed pursuant to ordering paragraph 5 of this Order shall reference the number of this case and shall be retained in the post-case correspondence file.

7. This case is closed and removed from the Commission's docket.
