ORDER

On August 21, 2019, Natural Energy Utility Corporation (Natural Energy) filed its Gas Cost Recovery (GCR) rate report to become effective October 1, 2019. After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Natural Energy's report includes revised rates designed to pass on to its customers its expected change in gas costs.
2. Natural Energy's report sets out an Expected Gas Cost (EGC) of \$3.2192 per Mcf, which is an increase of \$.0531 per Mcf from its previous EGC of \$3.1661 per Mcf.
3. Natural Energy's report sets out no Refund Adjustment.
4. Natural Energy's report sets out a current quarter Actual Adjustment (AA) of (\$.1549) per Mcf. Natural Energy's total AA is (\$.4106) per Mcf, which is an increase of \$.0491 per Mcf from its previous total AA of (\$.4597) per Mcf.
5. Natural Energy's GCR is \$2.8086 per Mcf, which is an increase of \$.1022 per Mcf from its previous GCR of \$2.7064 per Mcf.

6. The rates as proposed by Natural Energy and set forth in the Appendix to this Order are fair, just, and reasonable and should be approved for final meter readings by Natural Energy on and after October 1, 2019.

7. Should Natural Energy purchase sustainable natural gas from a renewable source during the reporting period of any future GCR reports then the supplier, cost, and amount must be documented in its cover letter to the Commission.

IT IS THEREFORE ORDERED that:

1. The rates proposed by Natural Energy and set forth in the Appendix to this Order are approved for final meter readings on and after October 1, 2019.

2. Within 20 days of the date of entry of this Order, Natural Energy shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.

3. This case is closed and removed from the Commission's docket.
