ORDER

This matter arises upon a motion to amend the procedural schedule filed on December 20, 2019, by the city of Murray, Kentucky, (Murray). On November 13, 2019, Murray Water District #2 (Murray District #2) and Murray (collectively, Joint Applicants) filed an application requesting an order to approve the transfer of ownership of Murray District #2 to Murray. On November 26, 2019, the Commission established a procedural schedule that required Joint Applicants to file responses to the initial requests for information by December 20, 2019. In its motion, the Murray requested to amend the procedural schedule to allow the Joint Applicants to have until January 10, 2020, in which to file responses to the initial requests for information.

As a basis for the motion, Murray stated that due to the holidays and vacation scheduling, key employees, including but not limited to Murray's chief financial officer, have been unavailable to participate in gathering the requested information.

Having reviewed the motion and being otherwise sufficiently advised, the Commission finds that Murray established good cause to amend the procedural schedule and that the motion should be granted.

IT IS THEREFORE ORDERED that:

1. Murray's motion to amend the procedural schedule is granted.
2. The procedural schedule in the November 26, 2019 Order is stricken and replaced with the amended procedural schedule attached as an Appendix to this Order.
