OPENING ORDER

Carter Douglas Company, LLC (Carter Douglas) has been named as a party to an investigation before the Kentucky Public Service Commission (Commission) for allegedly violating the Kentucky Underground Facility Damage Prevention Act (Act).¹

Pursuant to KRS 278.495(2), the Commission has jurisdiction to regulate the safety of natural gas facilities in Kentucky and to enforce minimum federal pipeline safety standards. Under the Act, the Commission has authority to investigate and assess civil penalties for any violation of the Act that results in excavation damage to an underground facility used to transport natural gas or hazardous liquid subject to federal pipeline safety laws, 49 U.S.C. § 60101, *et seq.* Any person who violates any provision of the Act is subject to assessment of a civil penalty in the amount of \$250 for the first offense, no more than \$1,000 for the second offense within one year, and no more than \$3,000 for the third and any subsequent offense. Additionally, any person whose violation of the Act results in damage to an underground facility containing any flammable, toxic, corrosive,

or hazardous material or results in the release of any flammable, toxic, corrosive, or hazardous material is subject to an additional penalty of up to \$1,000.

Following receipt of a report of excavation damage to its underground gas pipeline from an operator, Commission Staff (Staff) conducted an investigation and prepared an Incident Report, a copy of which is attached to this Order as an Appendix. In its Incident Report, Staff cites Carter Douglas for violation of the following provisions of the Act:

KRS 367.4911(2) – Locate requests are valid for twenty-one (21) calendar days from the day of the initial request.

and

KRS 367.4911(6) – The excavator shall protect and preserve temporary underground facility markers until the scheduled excavation or demolition is complete.

Based on its review of the Incident Report and being otherwise sufficiently advised, the Commission finds *prima facie* evidence that Carter Douglas violated the Underground Facility Damage Prevention Act. The Commission further finds that a formal investigation into the excavation damage incident should be conducted.

IT IS THEREFORE ORDERED that:

1. Carter Douglas shall submit to the Commission a written response to the

allegations contained in the Staff Incident Report within 20 days of receipt of this Order.

2. Any partnership, corporation, or business entity (including a limited liability company) must be represented by an attorney licensed to practice law in Kentucky, and such representation includes the filing of papers with and appearances at hearings before the Commission.

3. The Staff Incident Report 21084 in the Appendix to this Order is made a part of the record in this case.



Incident

The Operator reports the Excavator was installing a storm drain with a track hoe and damaged a 3/4" services. Locate Tickets 1809261284 dated 09/26/18 and 1810220240 dated 10/22/18 were obtained. The first was expired and the second was obtained after the damages occurred on 10/19/18. The area was located on the first ticket, however due to heavy excavation traffic locate marks were not visible.

Investigation

A review of the above stated Locate Tickets revealed that the Carter Douglas Company obtained Locate Ticket 1809261284 on 09/26/18 with an expiration date of 10/16/18 indicating said ticket expired approximately three days prior to the Incident Date of 10/19/18. Locate Ticket 1810220240 was obtained on 10/22/18 three days post the Incident Date of 10/19/18.

On 06/03/19 attempts to contact the Carter Douglas Co. resulted in messages being left at 270-847-9763 and 918-267-9001 ext. one, Wayne Cates, with no return call.

On 06/06/19 attempts to contact the Carter Douglas Co. at 918-267-9001 ext. two resulted in speaking to Will Salmon whom stated that he no longer was with the Company and was unable to provide additional Information.

On 06/06/19 contact was made with Matt Alsept at 918-267-9001 extension three whom stated that the Kentucky office was closed, he was no longer with the Company and the Oklahoma

office should be contacted.

On 06/06/19 contact was made with Joey Shoulders 918-267-9001 extension four whom stated he was no longer with the Company, but knew of the above incident. Mr. Shoulders stated that the gas line was damaged the day before with a track hoe and discovered the next day. Mr. Shoulders stated that he was unaware that the Locate Ticket was expired. Mr. Shoulders provided the owner, Wayne Cates's, phone number, 270-221-5556.

On 06/06/19 an attempt to contact Mr. Cates (270-221-5556) resulted in a voice mail message being left.

On 06/06/19 Mr. Cates made contact leaving a message to contact him through email, <u>wayne@carterdouglas.com</u>.

On 06/07/19 an email was sent to Mr. Cates requesting a response to the above incident.

On 06/11/19 Mr. Cates, via email, stated that he would have to look into the dates, the Carter Douglas Co. has been shut down and any mailings should be sent to 109 Robins Way Russellville, KY 42276.

On 06/18/19 Mr. Cates was sent a follow-up email. Mr. Cates advised, "Have not looked at dates but like I said before carter douglas company has been shut down (sic)"

The above noted Damage Report indicates:

The Carter Douglas Co. was installing a storm drain with a track hoe and damaged a 3/4" services. Locate Tickets 1809261284 dated 09/26/18 and 1810220240 dated 10/22/18 were obtained. The first was expired and the second was obtained after the damages occurred on 10/19/18. The area was located on the first ticket, however due to heavy excavation traffic locate marks were not visible.

The above allegations indicate violations may have occurred involving KRS 367.4911, (2) Locate requests are valid for twenty-one (21) calendar days from the day of the initial request and (6) The excavator shall protect and preserve temporary underground facility markers until the scheduled excavation or demolition is completed.

This alleged violation of KRS 367.4911 (2) & (6) imposes a penalty of \$1,250.00 for the first offense, but \$1,000 of the penalty may be suspended contingent upon completion of the KY Public Service Commission's Damage Prevention Course.

If you do not agree with the above allegation that a violation occurred please provide supporting documentation/evidence that the Carter Douglas Co. was in compliance with KRS 367.4911 (2) & (6).

If you agree that the Carter Douglas Co. is in violation of KRS 367.4911 the KY Public Service Commission will mail a Demand Letter requesting payment of the penalty of \$250.00 and the date the Damage Prevention course will be held. If you chose not to attend the Damage Prevention course the full penalty of \$1,250.00 will be imposed.
