ORDER

A hearing in the above-styled matter was held at the offices of the Kentucky Public Service Commission, 211 Sower Boulevard, Frankfort, Kentucky on March 8, 2019. The Commission finds that the formal hearing should be continued to June 19, 2019, at 10:00 a.m. Eastern Daylight Time in order to complete the evidentiary record. The Commission further finds that Drakesboro should file a response to the Commission's Order entered February 28, 2019 that initiated this case (February 28, 2019 Order) and to the deficiencies cited in the February 26, 2019 Staff Inspection Report attached as an Appendix to the February 28, 2019 Order.

IT IS HEREBY ORDERED that:

1. Drakesboro shall submit to the Commission, by the close of business on or before March 22, 2019, a written response to the February 28, 2019 Order and to the deficiencies enumerated in the February 26, 2019 Staff Inspection Report attached as an Appendix to the February 28, 2019 Order.

2. The hearing in this matter is continued to 10:00 a.m. Eastern Standard Time on June 19 and 20, 2019 at the Commission's offices at 211 Sower Boulevard in

Frankfort, Kentucky, for the purpose of presenting evidence concerning the alleged violations of 49 C.F.R. Part 192 and 807 KAR 5:027, and of showing cause why it should not be subject to the penalties prescribed in KRS 278.992(1) for these alleged violations.
