COMMISSION STAFF'S POST-HEARING REQUEST FOR INFORMATION
TO THE CITY OF DRAKESBORO, KENTUCKY

The city of Drakesboro, Kentucky, d/b/a Drakesboro Natural Gas Company (Drakesboro), pursuant to 807 KAR 5:001, is to file with the Commission the original and an electronic version of the following information. The information requested herein is due on December 3, 2019. Responses to requests for information in paper medium shall be appropriately bound, tabbed, and indexed. Electronic documents shall be in portable document format (PDF), shall be searchable, and shall be appropriately bookmarked.

Each response shall include the name of the witness responsible for responding to the questions related to the information provided. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.


Drakesboro shall make timely amendment to any prior response if Drakesboro obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any request to which Drakesboro fails or refuses to furnish all or part of the requested information, Drakesboro shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention shall be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations. When filing a paper containing personal information, Drakesboro shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

1. Provide an itemization of expenses that Drakesboro contends it incurred specifically to remedy the violations of pipeline safety standards set forth in Commission Staff's Standard Inspection Report dated February 26, 2019.
2. Provide copies of receipts, invoices, records, or other documentation of the expenses identified in response to the preceding request for information.
3. Provide copies of any agreements Drakesboro has made with any engineering firm concerning the potential upgrade, maintenance, or replacement of its natural gas distribution system or any component of that system.

4. Provide copies of any funding applications made by Drakesboro or on Drakesboro's behalf in relation to the potential upgrade, maintenance, or replacement of its natural gas distribution system or component of that system.

5. Provide copies of any agreements Drakesboro has made with any entity regarding a rate study of its natural gas distribution system.
