ORDER

On July 23, 2019, the Commission, on its own motion, scheduled an evidentiary hearing in this proceeding to be held on August 22, 2019. Thereafter, Mountain Water District (Mountain District) filed a motion to reschedule the hearing due to a scheduling conflict on the part of one of its attorneys. A telephonic conference between the Commission and counsel for each of the parties was held on Tuesday, July 30, 2019, at 3 p.m., at which time the parties agreed that the hearing in this case be rescheduled for September 11, 2019, at 9 a.m. Eastern Daylight Time.

IT IS THEREFORE ORDERED that:

1. The hearing scheduled for Thursday, August 22, 2019, at 9 a.m. Eastern Daylight Time, is canceled and rescheduled for Wednesday, September 11, 2019, at 9 a.m. Eastern Daylight Time, at the offices of the Public Service Commission at 211 Sower Boulevard, Frankfort, Kentucky.

2. The city of Pikeville (Pikeville) shall give notice of the hearing in compliance with 807 KAR 5:001, Section 9(2)(b). In addition, the notice of hearing shall include the following statement: "This hearing will be streamed live and may be viewed on the PSC

website, psc.ky.gov.” At the time, the notice is mailed or publication is requested, Pikeville shall forward a duplicate of the notice and request to the Commission.

3. Pursuant to KRS 278.360 and 807 KAR 5:001, Section 9(9), a digital video transcript shall be made of the hearing.


