ORDER

The Commission, on its own motion, finds that the procedural schedule in this matter should be amended and that a hearing should be scheduled for the purpose of taking evidence on the issues within the scope of this investigation of East Kentucky Power Cooperative, Inc.'s (EKPC) 2019 Integrated Resource Plan.

IT IS THEREFORE ORDERED that:

1. The procedural schedule in the July 5, 2019 Order is stricken and replaced with the amended procedural schedule attached as an appendix to this Order.
2. A hearing in this matter shall be held on Thursday, August 20, 2020, at 9 a.m. Eastern Daylight Time, in the Richard Raff Hearing Room (Hearing Room 1) at the offices of the Public Service Commission at 211 Sower Boulevard, Frankfort, Kentucky.
3. EKPC shall give notice of the hearing in compliance with 807 KAR 5:001, Section 9(2)(b). In addition, the notice of hearing shall include the following statement: "This hearing will be streamed live and may be viewed on the PSC website, psc.ky.gov." At the time the notice is mailed or publication is requested, EKPC shall forward a duplicate of the notice and request to the Commission.

4. Pursuant to KRS 278.360 and 807 KAR 5:001, Section 9(9), a digital video transcript shall be made of the hearing.


