ORDER

The Commission, on August 14, 2019, issued an Order in this proceeding conditionally approving Bluegrass Water Utility Operating Company, LLC's (Bluegrass Water) acquisition of P.R. Wastewater Management, Inc. (P.R. Wastewater); Marshall County Environmental Services, LLC (Marshall County Environmental); LH Treatment Company, LLC (LH Treatment); Kingswood Development, Inc. (Kingswood); Airview Utilities, LLC (Airview); Brocklyn Utilities, LLC (Brocklyn); Fox Run Utilities, LLC (Fox Run); and Lake Columbia Utilities, Inc. (Lake Columbia). In approving Bluegrass Water's acquisition of the various utilities the Commission required, *inter alia*, that within 90 days of the date of closing, P.R. Wastewater, Marshall County, LH Treatment, Kingswood, Airview, Brocklyn, Fox Run, and Lake Columbia to Bluegrass Water, each entity should file with the Commission a final annual report covering the reporting period of January 1,

2019, to the date of closing, in addition to any outstanding annual reports for periods prior to the calendar year 2019.¹

Bluegrass Water and the majority of the acquired utilities have complied with the conditions imposed by the August 14, 2019. However, neither Marshall County nor Lake Columbia filed their respective final annual reports. Repeated attempts by Commission Staff to obtain the annual reports were met with no response.

The Commission finds, that due to the passage of time since the issuance of the Order approving the acquisition of Marshall County and Lake Columbia and the fact that Marshall County and Lake Columbia have not existed as utilities since late September 2019 when Bluegrass Water closed on the acquisitions of each system, Marshall County and Lake Columbia should be relieved of the obligation of filing the annual reports. The Commission also finds that with the relief from this condition all conditions of the August 14, 2019 Order have been met and that this case should be closed and removed from the Commission's active docket.

IT IS THEREFORE ORDERED that:

1. Marshall County and Lake Columbia are not required to file the annual reports required by the August 14, 2019 Order.
2. This case is closed and removed from the Commission's active docket.
