RE: Informal Conference of February 10, 2025

Pursuant to a Staff Notice issued on February 3, 2025, an informal conference (IC) was conducted on February 10, 2025. Attached is a copy of the attendance roster.

The purpose of the IC was to discuss Estill County Water District's (Estill District) water loss surcharge monitoring and reporting process, including actions that increased the effectiveness of the water loss reduction activities.

Staff led the conversation and inquired into Estill District's experience with the water loss surcharge. Estill District expressed several suggestions in improving the process as it pertains to funding requests and clarity in orders. Estill District also discussed the projects that were most beneficial to reducing unaccounted-for water loss, the impact of having outside engineers involved early in the planning process, and other sources of funding it was able to utilize to decrease the unaccounted water loss.

There being no further discussion, the IC was then adjourned.
