ORDER

On June 12, 2019, Marion County Water District (Marion District) applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

Having reviewed the record and being otherwise sufficiently advised, the Commission finds that:

1. Marion District purchases water from the Campbellsville Municipal Water and Sewer (Campbellsville) and the Lebanon Water Works Company (Lebanon Water).
2. Campbellsville notified Marion District that its wholesale rate would increase from \$1.97 per 1,000 gallons to \$2.35 per 1,000 gallons effective July 1, 2019. Marion District proposes to increase the water rates to its customers effective July 1, 2019, to reflect the increased cost of purchased water from Campbellsville.
3. Marion District proposed a purchased water adjustment factor of \$0.01 per 1,000 gallons in its application.
4. During the 12 months ended April 30, 2019, Marion District purchased 3,554,000 gallons of water from Campbellsville and 453,891,375 gallons of water from Lebanon Water. During the same period, Marion District sold 374,975,864 gallons of

water. The increase in the cost of purchased water is \$1,350.20, resulting in a purchased water adjustment factor of \$0.01 per 1,000 gallons.

5. The purchased water adjustment factor of \$0.01 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable and should be approved.

6. Marion District's proposed rates should be approved.

7. The rates as set forth in Appendix B to this Order are fair, just, and reasonable, and should be approved for water service rendered by Marion District on and after July 1, 2019.

IT IS THEREFORE ORDERED that:

1. The purchased water adjustment factor of \$0.01 per 1,000 gallons is approved.

2. The rates proposed by Marion District are approved.

3. The rates as set forth in Appendix B to this Order are approved for water service rendered by Marion District on and after July 1, 2019.


