





Notice is hereby given that Kirksville Water Association has filed an application with the Public Service Commission ("PSC") to adjust its water rates as a result of an increase from its supplier, Richmond Utilities. The proposed effective date is July 1, 2019. The proposed changes are as follows:

Rate Schedule	Current	Proposed	\$ Increase	% Increase
First 2,000 gallons	\$ 20.05	\$ 20.27	\$ 0.22	1.1%
Next 3,000 gallons	\$ 9.67	\$ 9.78	\$ 0.11	1.1%
Next 5,000 gallons	\$ 8.20	\$ 8.31	\$ 0.11	1.3%
Over 10,000 gallons	\$ 6.98	\$ 7.09	\$ 0.11	1.6%

The average bill for a customer using 3,800 gallons of water each month would increase 1.1% from \$37.46 to \$37.87 for an increase of \$0.41 in the average customer's monthly bill.
