ORDER

Louisville Gas and Electric Company (LG&E) has moved to reschedule the hearing set for October 15, 2019. In support of its motion, LG&E states that over half of the utility's witnesses have previously scheduled commitments out of town the week of the hearing.

Having considered the motion, the Commission finds that the motion should be granted.

IT IS THEREFORE ORDERED that:

1. LG&E's motion to reschedule the October 15, 2019, hearing is granted.
2. The hearing for LG&E, scheduled for October 15, 2019, in this matter is canceled.
3. LG&E shall appear in Hearing Room 1 of the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky, on October 8, 2019, at 9 a.m. Eastern Daylight Time, to submit itself to examination on the application of its Fuel Adjustment Clause from November 1, 2018, through April 30, 2019. Neither opening statements nor summaries of pre-filed testimony will be permitted.

4. No less than 7 days and no more than 21 days prior to the scheduled hearing, LG&E shall publish in a newspaper of general circulation in each area in which it serves, notice of the purpose, time, place, and date of the scheduled hearing. In addition, the notice of hearing shall include the following statement: "This hearing will be streamed live and may be viewed on the PSC website, psc.ky.gov."

5. LG&E shall file with the Commission no later than October 7, 2019, proof of publication of its notice for the hearing.

6. The official record of the proceeding shall be by digital video recording only.
