Please find the email below regarding our approval to go from withdrawing 2 MGD to 4 MGD. As we discussed this will roughly double the annual amount we have to pay to the USACE. In 2017 and 2018 we have paid \$84,055.73 and \$55,057.14 respectively. This is an average of \$69,556.44 annually. This expense on the 2018 PSC report was reported under the Contractual Services -Other as Water Treatment. Please let me know if any additional information is needed or if you have any questions.

The Louisville District has determined, utilizing water supply storage accounting practices, that the Carr Creek Water Commission (CCWC) may withdraw up to 2,052 acre-feet of water storage between now and the time in which a new, permanent increase in water supply storage equaling 4 MGD has been approved and executed via water supply agreement or the end of this calendar year of 2018, whichever comes first. During this time, the Louisville District understands that CCWC's daily rate of water withdrawal may fluctuate both above and/or below the approved 2 MGD limitation. The Louisville District acknowledges CCWC alerting us to their need for increased water supply storage and is working towards submitting a letter report and supplemental agreement to HQUSACE for review/approval. CCWC is encouraged to continue to work collaboratively with Louisville District in good faith to establish a new, permanent increase to 4 MGD.
