Pursuant to the Informal Conference held on March 5, 2020, and Staff Memo filed of record on March 9, 2020, the City of Henderson and Henderson Utility Commission d/b/a Henderson Municipal Power & Light propose the following procedural schedule:


1. Requests for intervention to be filed no later than **fourteen (14)** days following issuance of PSC Procedural Order;
2. Initial data requests to Big Rivers to be filed no later than **thirty (30)** days following issuance of PSC Procedural Order;
3. Big Rivers' responses to initial data requests to be filed no later than **twenty-one (21)** days after filing of initial data requests;
4. Supplemental data requests to Big Rivers to be filed no later than **fifteen (15)** days from filing date of Big Rivers' responses to initial data requests;
5. Big Rivers' responses to supplemental data requests to be filed no later than **fifteen (15)** days from filing date of supplemental data requests;
6. Intervenor Testimony, if any, in verified, prepared form to be filed no later than **twenty-one (21)** days from filing of Big Rivers' responses to supplemental data requests;

7. Data requests to Intervenor to be filed no later than **twenty-one (21) days** from filing of Intervenor Testimony;
8. Intervenor responses to initial data requests to be filed no later than **thirty (30) days** after filing of initial data requests;
9. Supplemental data requests to Intervenor to be filed no later than **fifteen (15) days** after filing of Intervenor responses to initial data requests;
10. Intervenor responses to supplemental data requests to be filed no later than **fifteen (15) days** from filing of supplemental data requests;
11. Big Rivers' Rebuttal Testimony, if any, in verified, prepared form to be filed no later than **twenty-one (21) days** after filing of Intervenor responses to supplemental data requests;
12. Public Hearing to be held in Hearing Room No. 1 of the Kentucky Public Service Commission offices at 211 Sower Blvd., Frankfort, Kentucky, for purposes of cross-examination of witnesses of Big Rivers and Intervenor **TO BE SCHEDULED**;
13. Briefs **TO BE SCHEDULED**.
