INTRA-AGENCY MEMORANDUM

RE: Informal Conference of August 21, 2019

Pursuant to a Staff Notice, a telephonic informal conference (IC) was conducted on August 21, 2019. Attached is a copy of the attendance roster.

The purpose of the IC was to clarify the proposed rate adjustment contained in the application filed pursuant to KRS 278.023.

Big Sandy Water District (Big Sandy District) operates two divisions, Division 1, Original Big Sandy Water District Area, and Division 2, Overland Development Area. Division 2 has higher rates than Division 1. Further, Division 2 has only 5/8 meters, while Division 1 has six meter sizes, with rates specific for each meter size. Additionally, Big Sandy District sells water to Cannonsburg Water District at a wholesale rate.

In processing the case, Commission Staff (Staff) became aware of an ambiguous reference to rates applicable to Division 2 and Cannonsburg Water District. The customer notice for the proposed rate adjustment is attached as an attachment to this IC memo. The notice contained proposed rates broken out by meter size that comport with the tariff for Division 1; these proposed rates included the new monthly rate, the dollar change, and the percent change. The notice does not include present and proposed rates, and amount of change in dollar amount and percentage amount for Division 2 or Cannonsburg, but instead read, "Same as above."

Staff asked Big Sandy District to clarify whether the Division 2 rates and Cannonsburg Water District would mirror the rates for Division 1 or whether their rates would remain the same as in the current tariff. Big Sandy District confirmed that it intended to change the current tariffed rates for Division 2 and Cannonsburg Water District to the rates contained in the attached notice. Big Sandy District agreed to amend its application or otherwise make a filing that reflected said changes.

There being no further discussion, the IC was then adjourned.
