Excavation Damage: Failure to support exposed facilities

Description of Incident Chad Peercy was using a backhoe to dig a ditch to install a drainage pipe when he hit and broke a 3/4-inch plastic service line.

Summary Information

1/30/2019

Full details such as the cause	Chad Peercy called 811 to request a line location prior to excavating. The line was located and marked correctly by a Delta employee. Mr. Peercy exposed the service line prior to excavating. The service line broke when he used the backhoe to remove some tree roots.
Extent of the damage	There were no injuries or property damage attributable to this incident. Delta employees replaced two feet of 3/4-inch plastic pipe and installed two permasert couplings.
Cost of the damage	\$182.00
Steps taken to prevent re-occurrence	Mr. Peercy was advised to be more cautious when working around an exposed gas line.
