COMMISSION STAFF'S SECOND REQUEST FOR INFORMATION
TO BLUEGRASS WATER UTILITY OPERATING COMPANY, LLC,
CENTER RIDGE WATER DISTRICT, INC., JOANN ESTATES UTILITIES, INC.,
AND RIVER BLUFFS, INC.

Bluegrass Water Utility Operating Company, LLC, (Bluegrass Water), Center Ridge Water District, Inc., (Center Ridge Water), Joann Estates Utilities, Inc., (Joann Estates), and River Bluffs, Inc., (River Bluffs), (collectively, Joint Applicants), pursuant to 807 KAR 5:001, is to file with the Commission the original and an electronic version of its responses to the following information. The information requested herein is due on December 20, 2019. Responses to requests for information in paper medium shall be appropriately bound, tabbed, and indexed. Electronic documents shall be in portable document format (PDF), shall be searchable, and shall be appropriately bookmarked.

Each response shall include the name of the witness responsible for responding to the questions related to the information provided. Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity

that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Joint Applicants shall make timely amendment to any prior response if Joint Applicants obtain information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any request to which Joint Applicants fail or refuse to furnish all or part of the requested information, Joint Applicants shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention shall be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When filing a paper containing personal information, Joint Applicants shall, in accordance with 807 KAR 5:001, Section 4(10), encrypt or redact the paper so that personal information cannot be read.

1. Refer to Joint Applicant's response to Commission Staff's First Request for Information, Item 2, the \$36.80 refund Center Ridge Water was ordered to pay to Peggy S. Rose in Case No. 2017-00359 and the \$2,500 penalty Center Ridge Water was ordered to pay in Case No. 2017-00359.
 - a. Confirm that Center Ridge Water will pay the \$2,500 penalty and provide a date certain by which the penalty will be paid.
 - b. Confirm that Center Ridge Water will pay the \$36.80 refund to Peggy S. Rose and provide a date certain by which the refund will be paid.
