In accordance with 807 KAR 5:001, Section 8, **Duke Energy Kentucky, Inc.** gives notice of its intent to file an application for **Gas Cost Adjustment** with the Public Service Commission no later than **October 31, 2019** and to use the electronic filing procedures set forth in that regulation.
