ORDER

On November 22, 2019, Bluegrass Gas Sales, Inc., (Bluegrass) filed its proposed Gas Cost Recovery (GCR) rate report to be effective January 1, 2020. After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Bluegrass's report includes revised rates designed to pass on to its customers its expected change in gas costs.
2. Bluegrass's report sets out an Expected Gas Cost (EGC) of \$4.1403 per Mcf, which is an increase of \$.1192 per Mcf from its previous EGC of \$4.0211 per Mcf.
3. Bluegrass's report sets out no Refund Adjustment.
4. Bluegrass's report sets out a current quarter Actual Cost Adjustment (ACA) of (\$.0242) per Mcf. Bluegrass's total ACA is \$.2906 per Mcf, which is a decrease of \$.0238 per Mcf from its previous total ACA of \$.3144 per Mcf.
5. Bluegrass's report sets out a current quarter Balance Adjustment (BA) of (\$.0053) per Mcf. Bluegrass's total BA is \$.0330 per Mcf, which is a decrease of \$.0109 per Mcf from its previous total BA of \$.0439 per Mcf.
6. Bluegrass's GCR rate is \$4.4639 per Mcf, which is an increase of \$.0845 per Mcf from its previous GCR rate \$4.3794 per Mcf.

7. The rates set forth in the Appendix to this Order are fair, just, and reasonable and should be approved for service rendered by Bluegrass on and after January 1, 2020.

8. Should Bluegrass purchase sustainable natural gas from a renewable source during the reporting period of any future GCR reports then the supplier, cost, and amount must be documented in its cover letter to the Commission.

IT IS THEREFORE ORDERED that:

1. The rates proposed by Bluegrass and set forth in the Appendix to this Order are approved for service rendered on and after January 1, 2020.


