ORDER

On November 25, 2019, Millennium Energy, Inc., (Millennium) filed its proposed Gas Cost Recovery (GCR) rate report to be effective January 1, 2020. After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Millennium's report includes revised rates designed to pass on to its customers its expected change in gas costs.
2. Millennium's report sets out an Expected Gas Cost (EGC) of \$3.0920 per Mcf, which is an increase of \$.2983 per Mcf from its previous EGC of \$2.7937 per Mcf.
3. Millennium's report sets out no supplier Refund Adjustment.
4. Millennium's report sets out a current quarter Actual Adjustment (AA) of (\$.1885) per Mcf. Millennium's total AA is (\$.2581) per Mcf, which is a decrease of \$.1760 per Mcf from its previous total AA of (\$.0821) per Mcf.
5. Millennium's report sets out a current quarter Balance Adjustment (BA) of (\$.0044) per Mcf. Millennium's total BA is (\$.0230) per Mcf, which is a decrease of \$.0082 per Mcf from its previous total BA of (\$.0148) per Mcf.
6. Millennium's GCR rate is \$2.8109 per Mcf, which is an increase of \$.1141 per Mcf from the previous GCR rate of \$2.6968 per Mcf.

7. The rates set forth in the Appendix to this Order are fair, just, and reasonable and should be approved for service rendered by Millennium on and after January 1, 2020.

8. Should Millennium purchase sustainable natural gas from a renewable source during the reporting period of any future GCR reports then the supplier, cost, and amount must be documented in its cover letter to the Commission.

IT IS THEREFORE ORDERED that:

1. The rates proposed by Millennium and set forth in the Appendix to this Order are approved for service rendered on and after January 1, 2020.


