ORDER

1. Ordering paragraph 15 on page 28 of the August 6, 2020 Order shall be revised to state as follows: "BREC shall, within 14 days of the date of this Order, file with the Commission the accounting entries made on its books to effectuate the creation of the regulatory assets."
