ORDER

A hearing on Kentucky Power Company's (Kentucky Power) 2019 Integrated Resource Planning Report was held at the offices of the Public Service Commission at 211 Sower Boulevard, Frankfort, Kentucky, on Thursday, December 11, 2020, at 9 a.m. At the conclusion of the witness testimony, Commission Staff and counsel for Kentucky Industrial Utility Customers requested to file post-hearing data requests. In addition, the Commission, on its own motion, finds it necessary to amend the procedural schedule issued on October 14, 2020.

IT IS THEREFORE ORDERED that:

1. Post-hearing data requests, if any, shall be filed on or before December 11, 2020.
2. Responses to post-hearing data requests shall be filed on or before December 22, 2020.
3. Pursuant to 807 KAR 5:058, Section 11(3), Commission Staff shall enter its Staff Report summarizing its review of Kentucky Power's 2019 Integrated Resource Planning Report and offering suggestions and recommendations to Kentucky Power for subsequent filings into the record of this proceeding on or before February 15, 2021.

4. Any party desiring to file comments regarding Kentucky Power's 2019 Integrated Resource Planning Report or comments with respect to the Staff Report shall do so on or before February 25, 2021.

5. Kentucky Power shall file comments with respect to the Staff Report and in response to Intervenor comments on or before March 8, 2021.
