ORDER

On January 23, 2020, Louisville Gas and Electric Company (LG&E) and Kentucky Utilities Company (KU) (jointly, LG&E/KU) submitted a joint application to, among other things, amend their Green Tariff Standard Rate Rider GT (Green Tariff) to increase the renewable energy output provided to customers through renewable purchase agreements (RPA) from a cumulative 50 megawatts (MW) to 125 MW. The application proposed that the modification become effective on March 31, 2020.

Pursuant to KRS 278.190(2), the Commission can suspend the operation of the tariff and defer the proposed change of service at any time before it becomes effective. At a formal conference on February 6, 2020, and in a February 12, 2020 Order, the Commission stated that an investigation cannot be completed by March 31, 2020, and committed to render its decision no later than May 15, 2020. Therefore, pursuant to KRS 278.190(2), the Commission will suspend the effective date of the proposed modifications up to and including May 15, 2020.

IT IS THEREFORE ORDERED that LG&E/KU's proposed modification of the terms of service for the Green Tariff is suspended up to and including May 15, 2020.
