Unopposed Motion By Windstream Kentucky East, LLC For
An Extension Of Time To Answer Or Satisfy Complaint

Windstream Kentucky East, LLC states in support of its motion for an extension through and including May 8, 2020 in which to satisfy or answer the complaint filed in this matter:

1. The Commission by Order dated April 15, 2020 directed Windstream East to satisfy or answer the complaint filed by South Central Telecommunications Cooperative, Inc. and South Central Telecom, LLC (“Complainants”) within 15 days.


2. The work that is the subject of the complaint is being performed for Windstream East by Triple D Communications. Since receiving the Complaint, Windstream East has had multiple communications with Triple D. Triple D Communications informs Windstream East that Triple D Communications anticipates completing the work that is the subject of the complaint by April 29, 2020.

3. Although Windstream East is informed by Triple D Communications that the subject work will be completed one day prior to the date for satisfying or answering the complaint, Windstream East requested that Complainants agree to a short extension until May 8, 2020 for its contractor to complete the subject work. The short extension will obviate the need for further filings or Commission review and action in the event the work is delayed for a short period past the anticipated April 29, 2020 completion date.

4. Complainants agreed on April 24, 2020 to a one-time extension through and including May 8, 2020 for Windstream East to satisfy or answer the complaint. Counsel for Complainants reviewed this motion and has authorized Windstream East to represent that Complainants do not object to the requested relief.

Wherefore, Windstream Kentucky East, LLC respectfully requests that the Commission grant it an extension through and including May 8, 2020 in which to answer or satisfy the complaint in this matter.


