
ORDER

On its own motion, the Commission finds that the procedural schedule issued on June 4, 2020, should be amended to allow for sufficient time to develop a robust record given the complexity of issues presented in this matter. The Commission initiated this proceeding to afford Johnson County Gas Company (Johnson County) and Hall, Stephens, and Hall Gas Company (Hall) the opportunity to present evidence that the cost of gas sold to Johnson County by Hall and the Gas Cost Recovery (GCR) component of Johnson County's rates were reasonable, and, if not, to provide a reason why Johnson County's and Hall's rates should not be reduced.

An amended procedural schedule is attached hereto as an Appendix to this Order and is incorporated herein.

IT IS THEREFORE ORDERED that the procedural schedule established on June 4, 2020, is stricken and replaced with the amended procedural schedule attached as an Appendix to this Order.
