ORDER

On July 22, 2020, the Commission ordered Martin County Water District (Martin District) to file monthly reports of its purchases from Evans Hardware. The Commission, on its own motion, finds that on a quarterly basis, beginning October 16, 2023, and continuing each quarter until further order of the Commission, Martin District should file a report listing all purchases made from Evans Hardware for the previous quarter by Martin District and by Alliance Water Resources (Alliance), instead of filing a monthly report of purchases from Evans Hardware. This is because filing quarterly reports will timely provide the Commission with the necessary information regarding purchases from Evans Hardware and promote administrative efficiency.

IT IS THEREFORE ORDERED that:


1. On a quarterly basis, beginning October 16, 2023, and continuing each quarter until further order of the Commission, Martin District shall file a quarterly report of all purchases made from Evans Hardware by Martin District and by Alliance for the previous quarter with a narrative justification for the purchase and explanation why the item purchases could not be obtained from another source or why the supply was not kept in inventory.

2. The quarterly report shall be filed in this proceeding by the 16th day of the month following the end of each quarter.

3. Martin District is relieved of the requirement to file a monthly report of its purchases from Evans Hardware established in ordering paragraph 9 of the Commission's July 22, 2020 Order entered in this proceeding.


