

ORDER

On December 28, 2020, Water Service Corporation of Kentucky (Water Service Kentucky) filed a motion requesting an extension of time to file documents in response the final Order issued on December 8, 2020. Water Service Kentucky requested additional time to file nonrecurring charges reflecting the marginal cost of each nonrecurring service to the Electronic Tariff Filing system. Water Service Kentucky also requested additional time for the evaluation of continuing the new customer account set-up fee. The final Order required Water Service Kentucky to file the documents within 20 days of the entry of the Order. As of April 28, 2021, the requested documents have been filed with the Commission. The Commission finds the request for an extension of time is now moot.

IT IS THEREFORE ORDERED that Water Service Kentucky's motion is denied as moot.
