ORDER

On May 26, 2020, Millennium Energy, Inc. (Millennium) filed its proposed Gas Cost Recovery (GCR) rate report to be effective July 1, 2020. After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Millennium's report includes revised rates designed to pass on to its customers its expected change in gas costs.
2. Millennium's report sets out an Expected Gas Cost (EGC) of \$2.5355 per Mcf, which is an increase of \$.1530 per Mcf from its previous EGC of \$2.3825 per Mcf.
3. Millennium's report sets out no supplier Refund Adjustment.
4. Millennium's report sets out a current quarter Actual Adjustment (AA) of (\$.2775) per Mcf. Millennium's total AA is (\$.5615) per Mcf, which is a decrease of \$.1406 per Mcf from its previous total AA of (\$.4209) per Mcf.
5. Millennium's report sets out a current quarter Balance Adjustment (BA) of \$.0111 per Mcf. Millennium's total BA is (\$.0100) per Mcf, which is an increase of \$.0183 per Mcf from its previous total BA of (\$.0283) per Mcf.
6. Millennium's GCR rate is \$1.9640 per Mcf, which is an increase of \$.0307 per Mcf from the previous GCR rate of \$1.9333 per Mcf.

7. The rates set forth in the Appendix to this Order are fair, just, and reasonable and should be approved for service rendered by Millennium on and after July 1, 2020.

8. Should Millennium purchase sustainable natural gas from a renewable source during the reporting period of any future GCR reports then the supplier, cost, and amount must be documented in its cover letter to the Commission.

IT IS THEREFORE ORDERED that:

1. The rates proposed by Millennium and set forth in the Appendix to this Order are approved for service rendered on and after July 1, 2020.


