ORDER

On November 11, 2020, the Attorney General of the Commonwealth of Kentucky, by and through the Office of Rate Intervention (Attorney General) filed a motion requesting a partial deviation from the filing requirements of 807 KAR 5:001, Sections 8(3) and 12(a), which require a paper copy of electronically filed documents, and from the July 14, 2020 procedural Order entered in this proceeding that required original documents to be filed within 30 days of the lifting of the current state of emergency.

As a basis for the motion, the Attorney General stated that many of the responses to certain data requests that were filed electronically on November 2, 2020, consist of Excel spreadsheets with a large number of tabs, and PDF files that contain 1,768 pages, and are so voluminous that they would require an undetermined number of binders and banker boxes; thus, it would be costly and an undue burden to print the Excel spreadsheets and PDF files. The Attorney General explained that he will provide the Excel and PDF files on a CD.

Having reviewed the motion and the material, and being otherwise sufficiently

advised, the Commission finds that the Attorney General established good cause to grant

the requested deviation because filing printed copies of the designated materials would

not be an efficient use of resources and would result in an undue burden. The Attorney

General will file the information into the case record on a CD. Further, all documents are

fully accessible on the Commission's website.

IT IS THEREFORE ORDERED that the Attorney General's motion requesting to

deviate from filing requirements of 807 KAR 5:001, Sections 8(3) and 12(a), from

documents list in Appendix A to his motion is granted.
