ORDER

On June 18, 2021, the Siting Board issued an Order conditionally granting a Certificate to Construct an approximately 96-megawatt alternating current photovoltaic electricity generation facility, subject to full compliance with mitigation measures and conditions prescribed in Appendix A of the Order. The Order contained identical errors on page 27 and page 5 of 10 of Appendix A, which incorrectly stated that “Northern Bobwhite must commit to fix or fully compensate the appropriate transportation authorities for any damage or degradation to roads or bridges that it causes or to which it materially contributes to.” The correct language is “Northern Bobwhite shall fix or pay for damage resulting from any vehicle transport to the project site in accordance with all transportation permits obtained from state and local road authorities.” The Order also contains two duplicative mitigation measures in Appendix A of the Order on page 2 of 10. Accordingly, both duplicative mitigation measures will be removed and stricken from the Order.

Finding that the June 18, 2021 Order should be amended, the Siting Board
HEREBY ORDERS, *nunc pro tunc*, that:

1. Numbered paragraph 3 on page 27 is stricken and is replaced with the following language:

Northern Bobwhite shall fix or pay for damage resulting from any vehicle transport to the project site in accordance with all transportation permits obtained from state and local road authorities.

2. Numbered paragraph 24 on page 5 of 10 of Appendix A is stricken and is replaced with the following language:

Northern Bobwhite shall fix or pay for damage resulting from any vehicle transport to the project site in accordance with all transportation permits obtained from state and local road authorities.

3. Numbered paragraph 9 on page 2 of 10 of Appendix A is stricken from the Order.

4. Numbered paragraph 11 on page 2 of 10 of Appendix A is stricken from the Order.

5. All other provisions of the Siting Board's June 18, 2021 Order that are not in conflict with the terms of this Order shall remain in effect.
