RE: Informal Conference of March 31, 2023

Pursuant to a Staff Notice issued on March 22, 2023, an informal conference (IC) was conducted on March 31, 2023. Attached is a copy of the attendance roster.

The purpose of the IC was to discuss water loss surcharge reporting requirements pursuant to the Order issued on July 7, 2020. Commission Staff briefly discussed the monthly surcharge activity reports, monthly water loss reports, and annual reports required from Farmdale Water District (Farmdale District). Commission Staff further discussed the Qualified Infrastructure Improvement Plan (QIIP) previously filed by Farmdale District on February 21, 2023 and requested the district file a supplement in the future to provide further detail regarding the district's plan for use of the surcharge funds to undertake projects to reduce unaccounted-for water loss.

There being no further discussion, the IC was then adjourned.
