ORDER

On December 1, 2021, Caldwell Solar, LLC (Caldwell Solar) filed a Motion for an extension of time to respond to Siting Board Staff's First Request for Information, Items 5, 28, 50, 52, 66, 80, 83-85, 88, and 91-92. In accordance with the procedural schedule entered November 1, 2021, Caldwell Solar's responses were due December 3, 2021.

As a basis for the motion, Caldwell Solar explained that it needed additional time to prepare and file these responses due to the number of questions and reduced number of business days to prepare the responses during the Thanksgiving holiday. Caldwell Solar stated that it would file its responses to the remaining data requests on December 3, 2021, and requested an extension until December 10, 2021, to respond to the cited data requests.

Having considered the motion, the Siting Board finds that Caldwell Solar established good cause to grant an extension of time, and therefore the motion is granted. Because supplemental data requests to Caldwell Solar have a procedural due date of December 22, 2021, the Siting Board reserves the right to file a third round of data

requests to ensure that a full analysis of the information requested in the responses due on December 10, 2021, is conducted.

IT IS THEREFORE ORDERED that:


1. Caldwell Solar's motion for an extension until December 10, 2021, to respond to requests numbers 5, 28, 50, 52, 66, 80, 83-85, 88, and 91-92 of Siting Board Staff's First Request for Information is granted.

2. The remainder of the procedural schedule shall remain in effect.

3. In the event that the Siting Board Staff requires additional information, it has leave to file a further set of requests after its supplemental requests are filed on December, 22, 2021.
