ORDER

On November 30, 2020, Kentucky-American Water Company (Kentucky-American) and the Attorney General of the Commonwealth of Kentucky, by and through the Office of Rate Intervention (Attorney General), filed a joint statement requesting to submit this matter for a decision based on the written record. The procedural schedule established by the Commission required the parties to file a statement by December 9, 2020, requesting either a hearing or that the matter be submitted for a decision based on the written record. In their joint statement, the parties stated that a hearing is not necessary, and requested to file briefs no later than December 9, 2020, with the matter submitted for a decision without a hearing.

Based upon the motion and the existing case record, the Commission finds that, once the parties file briefs to supplement the record, the case record will be sufficiently robust and the matter should be submitted for a decision based upon the written record.

IT IS THEREFORE ORDERED that:

1. Kentucky-American and the Attorney General shall file simultaneous briefs on or before December 9, 2020.

2. This matter shall stand submitted for a decision as of 12:01 a.m. Eastern Standard Time on December 10, 2020.
