ORDER

On August 2, 2021, the Commission issued a final Order in this matter addressing Bluegrass Water Utility Operating Company, LLC's application for a rate increase and construction approval. On page 86 of the final Order, the Commission included salary information that is currently being treated as confidential pursuant to 807 KAR 5:001, Section 13(4), due to a pending motion for confidential treatment. Specifically, the relevant sentence states:

This increase was driven in large part by significant raises projected for several employees, including CSWR's President, who was projected to receive a salary of [REDACTED] in the base period and a salary of [REDACTED] in the forecasted test year.

However, the final Order, as originally posted, did not redact the President's projected salary in the base or the forecasted period. Because a motion for confidential treatment was pending regarding the information, the specific projected salaries for CSWR, LLC's President should have been redacted from the public record and an unredacted version of the final Order should have been placed in the confidential file pending an Order addressing the motion for confidential treatment.

The Commission, on its own motion, HEREBY ORDERS, *nunc pro tunc*, that:

1. The August 2, 2021 Order included in the public file, including any online posting, shall be redacted such that the salaries in the sentence on page 86 of the final Order, quoted above, are not visible.
2. The original, unredacted final Order shall be placed in the confidential file and treated as confidential pursuant to 807 KAR 5:001, Section 13, pending an Order addressing the motion for confidential treatment or any lawful request for the information.
3. The August 2, 2021 Order shall remain in full force and effect.
