My name is Karen Ramsey and I live at 63 West Airview Dr. I purchased my home in Jan 2002. At that time Hardin Co Water #2 was doing the billing for water and for sewer. At some point and I dont recall when, Hardin Co Water stopped billing for the individuals that owned the treatment plant for this neighbor and we got billed separately. Around this time Airview utilities increased our bill to \$41.36. It was around \$28.00.

Airview Utilities made very little changes if any. Bluegrass Water only provides sewer for our neighborhood. Thank goodness for that, because I cant imagine the quality of water they would provide and feel for the folks that depend on them for water and sewer.

It appears to me that Blurgrass should have looked a little deeper into what they were purchasing. I'm told that our sewers are in horrible condition and that is why the plan didn't go through to hook up with Hardin Co.

As a home owner, I pay my Bill's and only pay a little over \$19 for my water. I live alone and rarly have a water bill over \$20. I just cant wrap my head around having to pay \$96.14 in sewer for \$19 in water.

I dont mind an increase, but not 132.4%. \$20 would be more reasonable if any. Please dont let Blurgrass Water do this to all the people in these neighborhoods. We are considered an low income neighbor, folks cant afford this. I know I cant.
