
ORDER

On September 21, 2020, Big Rivers Electric Corporation's (BREC) filed its 2020 Integrated Resource Plan (IRP) pursuant to 807 KAR 5:058. By Order issued on November 22, 2021, the Commission entered into the record of this case a report summarizing Commission Staff's review (Staff Report) of BREC's 2020 IRP. A hearing was conducted in this matter on November 23, 2021. Sierra Club filed post-hearing comments regarding BREC's IRP and the Staff Report on January 31, 2022. On February 11, 2022, BREC filed post-hearing comments regarding the Staff Report and intervenor comments and requesting an Order closing this case and setting a date for the next IRP to be filed. Based on the evidence of record and being sufficiently advised, the Commission finds that all substantive actions in this case have been completed and this case shall be closed and that BREC's next IRP shall be filed on or before September 29, 2023.

IT IS THEREFORE ORDERED that:

1. BREC shall file its next IRP no later than September 29, 2023.
2. This case is closed and removed from the Commission's docket.
