ORDER

On July 5, 2021, Horus Kentucky 1 LLC (Horus Kentucky 1), filed an application seeking a Construction Certificate to construct an approximately 69.3-megawatt merchant electric solar facility located in Simpson County, Kentucky. Having reviewed the application, the Siting Board finds that a procedural schedule should be established to ensure for the orderly processing of this proceeding. The Siting Board further finds, pursuant to 807 KAR 5:110, Section 6, that a public hearing should be tentatively scheduled in order to extend the statutory deadline from 120 days to 180 days for the processing of this matter.

IT IS THEREFORE ORDERED that the procedural schedule set forth in the Appendix to this Order shall be followed for this proceeding.
