ORDER

On August 5, 2021, John Pitt and Steve Baldwin (collectively, Intervenors), by counsel requested a public hearing be scheduled in this matter. Horus Kentucky 1 LLC (Horus Kentucky 1) filed a response to request for public hearing on August 31, 2021. The Siting Board established a procedural schedule by Order on July 28, 2021, which set a public hearing on November 15, 2021. The Siting Board finds that since a public hearing has been scheduled, the request for public hearing will be denied as moot.

IT IS THEREFORE ORDERED that:

1. Intervenors' request to schedule a public hearing is denied as moot.
2. A hearing in this matter shall be held November 15, 2021, at 1:30 p.m. Eastern Standard Time, in the Richard Raff Hearing Room at the offices of the Public Service Commission at 211 Sower Boulevard, Frankfort, Kentucky.
3. Horus Kentucky 1 shall give notice of any scheduled hearing in accordance with the provisions set forth in 807 KAR 5:110, Section 9. In addition, the notice of hearing shall include the following statement: "This hearing will be streamed live and may be

viewed on the PSC website, psc.ky.gov”; and “Public comments may be made at the beginning of the hearing. Those wishing to make oral public comments may do so by following the instructions listing on the PSC website, psc.ky.gov.”

4. Horus Kentucky 1 shall file notice of the scheduled hearing with the Siting Board in accordance with the provisions set forth in 807 KAR 5:110, Section 9.

5. At any public hearing in this matter, neither opening statements nor summarization of direct testimonies shall be permitted.

6. Pursuant to KRS 278.360 and 807 KAR 5:001, Section 9(9), a digital video recording shall be made of the hearing .
