ORDER

On June 2, 2021, West Carroll Water District (West Carroll District) and the city of Carrollton, on behalf of Carrollton Utilities (Carrollton) (collectively, the Joint Applicants), filed their motion for extension of time requesting an extension to file the documents requested in the Commission's April 28, 2021 Order. As grounds, the Joint Applicants explained that the merger is set to take place July 1, 2021, to coincide with the fiscal year for Carrollton. The Commission's Order required the Joint Applicants to file within 60 days from the date of the Order a financial and statistical report as required by 807 KAR 5:006, Section 4, for the reporting period from January 1, 2021, to the date of the merger. The deadline contained in the Order will be prior to the merger. The Joint Applicants request a 30-day extension to file the required report, which would make the filing due on July 27, 2021.


The Commission finds there is good cause to grant the extension of the deadline for the Joint Applicants to comply with the requirements of the April 28, 2021 Order.

1. The Joint Applicants' motion filed June 2, 2021, is granted.
2. The Joint Applicants shall comply with the requirements of the April 28, 2021 Order by July 27, 2021.
