ORDER

On May 28, 2021, Western Lewis-Rectorville Water and Gas District (Western Lewis-Rectorville District) filed its proposed Gas Cost Recovery (GCR) rate to be effective July 1, 2021. Western Lewis-Rectorville District's previous GCR rate was approved in Case No. 2021-00048.¹

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. Western Lewis-Rectorville District's report includes revised rates designed to pass on to its customers its expected change in gas costs.
2. Western Lewis-Rectorville District's report sets out an Expected Gas Cost (EGC) of \$4.8989 per Mcf, which is an increase of \$.3752 per Mcf from its previous EGC of \$4.5237 per Mcf.
3. Western Lewis-Rectorville District's report sets no Refund Adjustment (RA).
4. Western Lewis-Rectorville District's report sets out a current quarter Actual Adjustment (AA) of (\$.3299) per Mcf. Western Lewis Rectorville District's total AA is

(\$1.7006) per Mcf, which is a decrease of \$.4178 per Mcf from its previous total AA of (\$1.2828) per Mcf.

5. Western Lewis-Rectorville District's report sets out no Balance Adjustment.

6. Western Lewis-Rectorville District's GCR rate is \$3.1983 per Mcf, which is a decrease of \$.0426 per Mcf from the previous GCR rate of \$3.2409 per Mcf. Western Lewis-Rectorville District erroneously listed on the summary page for the calculation of the GCR the total AA as \$1.7006 per Mcf and not (\$1.7006) per Mcf. However, this typographical error did not impact the total GCR rate and it was correctly listed as \$3.1983 per Mcf.

7. The rates as set forth in the Appendix to this Order are fair, just and reasonable and should be approved for service rendered by Western Lewis-Rectorville District on and after July 1, 2021.

8. Should Western Lewis-Rectorville District purchase sustainable natural gas from a renewable source during the reporting period of any future GCR reports, then the supplier, cost, and amount must be documented in its cover letter to the Commission.

IT IS THEREFORE ORDERED that:

1. The rates proposed by Western Lewis-Rectorville District and set forth in the Appendix to this Order are approved for service rendered on and after July 1, 2021.

2. Within 20 days of the date of entry of this Order, Western Lewis-Rectorville District shall file with this Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets setting out the rates approved herein and reflecting that they were approved pursuant to this Order.

3. This case is closed and removed from the Commission's docket.
