ORDER

The Commission, on its own motion, finds that the Order entered on July 6, 2021, should be amended based on new information provided by West Shelby Water District (West Shelby District). The Commission further finds that because the July 6, 2021 Order closed this case, the case should be re-opened for the limited purpose of correcting Appendix B to the July 6, 2021 Order.

On July 6, 2021, the Commission entered an Order approving the rates proposed by West Shelby District and, among other things, required West Shelby District to file a tariff filing reflecting the approved rates. When reviewing the tariff filing submitted by West Shelby District, Commission Staff noted that the Order listed a 5-inch meter rate. According to its current tariff, West Shelby District does not have a 5-inch meter rate. On July 28, 2021, West Shelby District filed a notice¹ with the Commission stating that West Shelby District erroneously listed a 5-inch meter rate in its rate application. West Shelby District further stated that the rates should have been for a 6-inch meter.

Based upon the new information contained in the notice, post-hearing, and a review of the case record, the Commission finds that West Shelby District's rate schedule

contained in Appendix B to the July 6, 2021 Order should be stricken and replaced with the Appendix to this Order that contains the corrected rate schedule for West Shelby District.

IT IS THEREFORE ORDERED that:

1. The Commission opens this case for the limited purpose of addressing the new evidence regarding West Shelby District's rate schedule.
2. The rate schedule contained in Appendix B to the July 6, 2021 Order is stricken and replaced with the rate scheduled contained in the Appendix to this Order.
3. All other provisions of the July 6, 2021 Order not otherwise in conflict with this Order remain in full force and effect.
4. This case is closed and removed from the Commission's docket.
