ORDER

By Order entered October 6, 2023, the Commission scheduled a hearing in this matter for December 19, 2023, at 9 a.m. Eastern Standard Time. On December 4, 2023, the parties filed a joint motion to suspend the procedural schedule and cancel the hearing scheduled for December 19, 2023. In support of the motion, the parties stated that they have reached an agreement in principle to resolve their disputes, and that suspending the procedural schedule will allow the parties time to complete the written settlement agreement and submit it to the Commission for review and approval. The parties stated that they will file a written settlement agreement for approval by the Commission by December 11, 2023.

The Commission finds good cause to suspend the procedural schedule and cancel the hearing to allow the parties time to memorialize and file their settlement agreement. Resolution of this dispute by mutual agreement of the parties rather than by contested hearing will conserve the time and resources of the parties, counsel, and the Commission.

The Commission further finds that the parties should file their written settlement agreement with the Commission by December 13, 2023.

IT IS THEREFORE ORDERED that:

1. The procedural schedule in this proceeding is suspended pending further order of the Commission.

2. The hearing scheduled in this matter for December 19, 2023, is canceled.

3. The parties shall file their written settlement agreement into the record by December 13, 2023.
